FY2020 ICD-10-CM Guidelines

Procedure Coding System (ICD-10-PCS). These guidelines should be used as a companion document to the official version of the ICD-10-PCS as published on the CMS website. The ICD-10-PCS is a procedure classification published by the United States for classifying procedures performed in hospital inpatient health care settings.

ICD-10-PCS Official Guidelines for Coding and Reporting

U07.1, COVID-19. This is an exception to the hospital inpatient guideline Section II, H. In this context, "confirmation" does not require documentation of the type of test performed; the provider's documentation that the individual has COVID-19 is sufficient. Presumptive positive COVID-19 test results should be coded as confirmed. A

General Inpatient Coding Guidelines 1.1 Use both the alphabetic index and tabular listing when locating and assigning a code. You would be very surprised to learn how many coders assign incorrect codes because they "code" from the tabular list only. The index gives valuable information on how to classify the diagnosis.

Official ICD-9-CM Guidelines for Inpatient Coding and ...

The Official Coding Guidelines are published annually; the ICD-10-CM document is published by the Centers for Disease Control and Prevention (CDC) and the ICD-10-PCS document is published by the Centers for Medicare and Medicaid Services (CMS). Coding Clinic issues are published quarterly, and CPT Assistant is published monthly.

Facility coders should be well versed in all four sections of the ICD-10-CM Official Guidelines for Coding and Reporting: Section I explains coding conventions, along with general coding and chapter-specific guidelines. Section II gives directives on selecting the principal diagnosis (PDX).

The 2020 ICD-10-CM files below contain information on the ICD-10-CM updates for FY 2020. These 2020 ICD-10-CM codes are to be used for discharges occurring from October 1, 2019 through September 30, 2020 and for patient encounters occurring from October 1, 2019 through September 30, 2020.

2020 ICD-10-CM | CMS

Inpatient medical coding is reported using ICD-10-CM and ICD-10-PCS codes, which results in payments based on Medicare Severity-Diagnosis Related Groups (MS-DRGs). Outpatient medical coding requires ICD-10-CM and CPT®/HCPCS Level II codes to report health services and supplies.

Key Differences Between Inpatient Coding and Outpatient Coding

The official guidelines should be the basis on which all coding and sequencing decisions are made when the codebooks do not provide specific direction through the use of various conventions and notes. These guidelines were approved for use by hospitals/physicians in coding and outpatient services.

A: The Official Guidelines for Coding and Reporting tells us that a diagnosis documented as being uncertain during an inpatient stay must remain so at the time of discharge. Most people interpret this to mean that the

uncertain diagnosis must be documented in the discharge summary and available at the time of coding.

For infections following infusion, transfusion, therapeutic injection, or immunization, a code from subcategory T80.2, Infections following infusion, transfusion, and therapeutic injection, or code T88.0-, Infection following immunization, should be coded first, followed by the code for the specific infection.

The ICD-10-CM Official Guidelines for Coding and Reporting, Section I.C.19.g.3.a. state that “a transplant complication code is only assigned if the complication affects the function of the transplanted organ.” The COVID-19 infection has affected the function of the transplanted lung.

In the inpatient hospital setting, probable, suspected, and rule-out diagnoses cannot be reported by the facility as though the condition exists. False Assign Z01.89, Encounter for other specified special examinations, for encounters for routine laboratory/radiology testing in the absence of any signs, symptoms, or associated diagnoses.
